Thank you for expressing interest in serving on the Porsche Club of America (PCA) Diablo Region Board of Directors.

Diablo Region received its charter from PCA in 1984 and is incorporated in the State of California as a 501(c)(7) non-profit organization in accordance with the California Corporations Code.

The Board is responsible for the proper conduct of the administrative affairs of the Diablo Region, the proper functioning of the various committees, and compliance with the Region Bylaws.

Pursuant to the Region's Bylaws, the Board is comprised of seven (7) members. Director terms commence January 1<sup>st</sup> in the year following their election. Directors serve two-year terms that are staggered with four Directors being elected in even numbered years and three Directors elected in the odd numbered years. For the 2021 election, there are three (3) current Board vacancies to be filled.

Each year, the Board elects from among themselves the positions of President, Vice President, Secretary, Treasurer and Directors at Large. Board meetings are held monthly on the second Monday of the month, typically from 6:00 PM to 7:30 PM. Since the Covid-19 crisis, the Board has been meeting via conference call.

Once the Nominating Committee receives your application, we'll schedule a brief interview during the week of August Board meeting so that we may place names of qualified candidates in nomination before the Board at the August Board Meeting.
